Mr. Sherk, speaking for the Firehouse/Municipal Building Committee, commented on the painting completed a year ago and on carpeting recently installed in the meeting room to help control noise levels. For the Planning Committee, he mentioned briefly the meetings held regarding refinements of existing ordinances and the two hearings on applications for subdivisions of property.

Mr. Sherk in reporting for the Roads Committee noted the excellent cooperation of the Town, the milder winter and repair of potholes, etc. He also stated that the condition of signs is reviewed at least twice a year and corrective action taken; a problem exists in the removal (or taking of signs) by persons unknown.

The Chairman expressed a few comments on his impressions of the quality of life in Pine Orchard. He noted from a review of an 1880's document that the area had at that time been laid out in lots that still exist today. As to the quality of life, he spoke of the friendliness of the neighborhood, the neatness of the homes and gardens, the cooperation from the Town of Branford, the effectiveness of Pine Orchard zoning, the quietness and good behavior exhibited on the beaches, the dedication and work of the Executive Committee who serve without pay - plus no increase in taxes again this year. Not many communities can offer, as Pine Orchard does, dense woods to walk in, tennis and golf courses, a quiet away from thoroughfares, a lovely country club, boat facilities, safe streets - plus all the excellent recreational facilities of Branford. The community didn't just happen. It took careful thought and planning from such as Alden M. Young and Milton Warner, carried on by relatives and others - plus the guiding hands of Milton W. Goss and Sidney W. Noyes, Jr. and the last three Presidents, Messes. Buza, Usher and Gagge. The Chairman concluded his remarks noting that Pine Orchard is a legacy to be proud of & to be nurtured. Thoughts and suggestions should be brought to the Board or Committee Chairmen at any time.

The Chairman opened the meeting for questions from the floor. Constance Tyson asked about the responsibility for mowing the vacant lot on Hart Avenue. In this instance the owner will be contacted to see that it is done. Mrs. Tyson also asked about a Spring or Fall trash cleanup. It was noted that there is nothing in the town contract for this, and with a permit residents can transport such to the town dump. It was emphasized in response to this query and one by Mrs. Moore on quantity of trash that could be picked up, that it is the town's responsibility for trash collection under a town contract. Those with questions should call Mr. Prusski at 488-0524 as he holds the town contract.

Carl Schmid commented on the trash can (and raccoons) conditions in the Sunset Hill area and asked what could be done to have residents solve this problem. Birch Hincks spoke of the danger inherent on the curve at Selden and Yowago and asked whether traffic could be made one way. David Daggett noted the sinking condition of the breakwater and suggested setting aside funds for major repairs. Florence Weiffenbach questioned the status of repairs to the Birch Road bridge. In response, Mr. Tweed noted the past history of the bridge and that now repairs would probably fall under a federal project; it will take time (another year perhaps). Mrs. Moore spoke of the speeding on Island View and need to control, and Mrs. Ehinger noted there were no signs marking Ozone Road.

The Chairman thanked those present for coming and for their comments and indicated that the points raised bould be reviewed for necessary action.

He expressed his thanks also to the checkers (and tellers) and to the committee members. There being no further business the meeting was adjourned at 9:00 p.m.

There being more than twelve members present, the Vice-President, Mr. Sherk, as Chairman, declared a quorum and called the meeting to order at 8:05 p.m. Mr Sherk noted that he was serving as Chairman in the absence of Mr. Gagge, the Association's President, and that Mrs. Palisca was acting as Clerk in the absnece of Mr. Sherwood.

Mr. Sherk thanked the Pine Orchard Chapel Association for the use of the building for the meeting. He also tanked David Daggett and Christine Mauro for serving as checkers to identify qualified voters and provide them with ballots for the lection to follow.

The Clerk pro tem read the call of the meeting.

Upon a motion duly made, seconded and carried the reading of the minutes of the previous annual meeting of July 7, 1980 was waived.

The Chair declared the polls open for election by ballot of four persons to the Executive Board for a three year term. The nominees recommended by the Board in accordance with the by-laws were Jane A. Palisca, Edward L. Reynolds, F. Allen Sherk and John H. Tweed, Jr. There being no nominations from the floor, upon motion duly made, seconded and carried, the polls were closed and the Clerk was instructed to cast one ballot for the above nominees as listed.

Mr. Sherk presented the Vice-President's report, noting that the past year has been a good one for Pine Orchard with a minimum number of problems in a friendly community, and that much of the credit goes to the quiet effective work of people behind the scenes: Hazel Swanfelder, Manager of the Association Office, and William J. Hutchins, Jr., our police officer for twenty years. Concerning taxes, Mr. Sherk noted that the Branford taxes have about doubled for Pine Orchard residents, although the mill rate was halved; at first it seemed that there had been some discrimination against Pine Orchard, but recent house sales have proved that real estate in our area has appreciated more than the rest of the town. Locally in Pine Orchard the Board has held down expenses so that the current mill rate is about one-third of last year's, and taxes only slightly higher even with the newly assessed property values; the Grand List for Pine Orchard is \$26,279,166. Mr. Sherk concluded that the assessors had been conservative regarding Pine Orchard.

Mrs. van Wilgen presented the Treasurer's report as audited by Seward & Monde and their opinion as to the Association's fiscal status (copies attached). Receipts for the year were \$36,641 and disbursements were \$37,093. As of June 30, 1981 the cash balance was \$4,946 compared to \$5,399 a year earlier. As of the end of the fiscal year there remained an unpaid balance of \$19,000 on the notes issued in connection with the municipal building. Upon a motion duly made and seconded the Treasurer's report was approved and accepted.

Mr. Reynolds, Chairman of the Police committee, summarized statistical report (copy attached) of police activity for the Pine Orchard patrol. This report was prepared by Ptl. William J. Hutchins, Jr. Mr. Reynolds introduced Patrolman Hutchins on the occasion of his twentheth anniversary of service to Pine Orchard; the meeting responded with a standing ovation. Mr. Sherk read a portion of a letter from a resident who recently moved away in which he singled out Ptl. Hutchins for his service to the community. In response to a question from the floor about speeding on Elizabeth Street, Mr. Hutchins reminded the meeting that he drives an unmarked car and employs radar to apprehend violators.

Other committee reports ensued. Mrs. Kimball for Roads thanked the members of her committee for their assistance, requested the return of missing street signs and traffic signs, and invited members of the Association to call her about any problems. Mr. Healy reported for

Health the change in trash pick-up days to Wednesdays and Saturdays for all of Pine Orchard as of July 1 when the National Carting Company assumed the contract for the Town of Branford. Mr. Sherk, speaking for Mr. Buza, noted the extensive repairs made recently to the seawall and stairs, in addition to those made on the breakwater. Mr. Sherk also reported for Planning that seven zoning permits had been issued including two special careaptions, without recourse to the Board of Zoning Appeals.

The Chairman opened the meeting for questions from the floor. Tony Cipriano asked about trash pick-up on holidays; Mr. Healy responded that the Association has no authority concerning the schedule set up by the town. Earl Carlin inquired about the police patrol schedule; Mr. Reynolds explained that during the summer the police car is on duty on Saturdays and Sundays from noon until 2 a.m. with a varied schedule on weekdays and other seasons.

The problem of stray dogs prompted several comments and questions. Coral Moore suggested that Pine Orchard residents buy their own fertilizer instead of depending on local dogs. The Chairman reiterated the state law requiring dogs to be kept on a leash at all times, emphasized the attention given to the problem in the Association Newsletters, and explained that the dog warden cannot pick up strays without a call from someone. The police patrol report listed only 5 complains about dogs. Unless residents cooperate, there is little the Association can do. Florence Prann suggested sending a letter to residents about dogs; Mr. Usher replied by urging Mrs. Prann to mention the problem in her column on Pine Orchard in the Branford Review.

Coral Moore mentioned the poor state of repair of the walk to the beach in her area. Mrs. Eschrich asked about regulations concerning BB guns.

Parking and traffic problems were discussed. Mrs. Usher brought up the matter of parking on both sides of Selden Avenue; Mr. Reynolds will take this up with the police. Mrs. Hincks asked that Yowago be made a one-way street for the sake of safety. Mr. Reynolds replied that a survey made about five years ago by Milton W. Goss indicated that 90% of Yawago Avenue residents were not in favor. Mrs. Healy questioned the necessity of cars being required to park in the direction facing Elizabeth Street when parked on Yowago which has one-side parking only. This regulation was explained as a safety precaution. Mr. Eschrich and Mrs. Cipriano and Mrs. Sherk all spoke about one-side parking on Island View Avenue where cars must park in one direction only.

Barbara Edwards asked about police patrol at Young's Pond. Mr. Reynolds answered that our policement are instructed to spend five minutes per hour in that area. When our car is not on duty, the responsibility belongs to the Branford Police.

The Chairman remarked that a few moorings are still available at the Pine Orchard Breakwater for an annual fee of \$25. Residents interested should call David Daggett.

The Chairman thanked those present for coming and for their comments and indicated that the points raised could be reviewed for necessary action.

He Expressed his thanks also to the checkers and to the committe members, and mentioned again the Association's appreciation of the work of Hazel Swanfelder at our office at 8 Anchorage Road.

In addition to the listing of officers, committee heads etc. it was suggested that news items include information on how to contact the police (with who, why and where), how to contact dog warden or canine problems and data re National Carting and trash collection.

A brief discussion was held on the subject of police car marking and possible need for additional committee members. As to the repair of steps to the beach at the end of Spring Rock (the subject of a written note and verbal request), this has been referred to Mr. Buza.

Mr. Usher brought up a question (raised by some property owners) of whether Pine Orchard as a group should undertake the spraying of trees to combat such as the gypsy moth. This was not deemed practicable at this time.

Mr. Fletcher queried about the checking as to zoning compliance regarding the new residence on Elizabeth Drive. In view of the restrictions placed to grant the variance, this was referred to the Zoning Enforcement Board for compliance.

There being no further business the meeting was adjourned at 8:40 P. M.

Upon motion made the minutes of the Special Meeting of July 23, 1981 were approved as distributed.

The President noted a letter received from Victor J.
